## **PRESIDENT'S OFFICE**

### **EXECUTIVE ORDER**

*Approving Civil and Administrative Action*

**WHEREAS,** The President of the Seneca Nation has the authority and obligation to take actions deemed to be necessary to ensure the safety of the citizens of the Seneca Nation; and

**WHEREAS,** the President must exercise such authority to act against individuals that have a history of bringing harm to our communities in the form of drugs or violence; and

**WHEREAS,** Kelly Luke is known in the community as a drug dealer and user and Kelly Luke presents an ongoing danger to our Seneca children and our communities due to ongoing drug related activities that are occurring within his residence; and

**WHEREAS,** over the years, Kelly Luke has been present at drug overdoses at his residence, which have resulted in death, including most recently the death of a Seneca; and

**WHEREAS,** Kelly Luke has shown through his course of conduct to be a danger to our communities, to be indifferent to Seneca life, and to be a threat to the Nation.

#### **IT IS HEREBY ORDERED THAT,**

Effective immediately, Kelly Luke is prohibited from entering any Nation building or business. The sole exceptions to this provision are for Kelly Luke (1) to appear before the Nation's courts to defend any actions pursued against him as a result of his conduct, or (2) to attend to a scheduled appointment for federally funded services at the Nation's health centers; but in either instance Kelly Luke must first give advance notice to the Nation's Marshals and the President at least 24 hours in advance of such appearance or appointment; and

**IT IS FURTHER ORDERED THAT,**


Effective immediately all annuity payments, disability benefits, any direct health and welfare payments, and any other payments from the Nation's general fund ("Direct Benefits") to Kelly Luke are hereby forfeited for three years and shall not be resumed until such time as Kelly Luke comes before Council, in a session of Council, to request the resumption of payment of such Direct Benefits and such request is granted; and

**IT IS FURTHER ORDERED THAT,**

Effective immediately, Kelly Luke shall not have the privilege of, and is prohibited from, conducting any commercial activity within Nation territory and all Nation licensed businesses are prohibited from doing business with Kelly Luke.
